

We don't dictate solutions – we listen, collaborate, and co-create. By engaging stakeholders, we develop strategies that address real challenges in the research landscape.






Support tailored to the research community.

Our close engagement with researchers and research organisations enables us to design resources, tools, and support that meet a wide range of needs – from universities and funders to publishers, policymakers, and science communicators.

Convening stakeholders





Challenges in research integrity cannot be solved in isolation. **UKRIO acts as a convener**, bringing together voices from across sectors and disciplines to co-create solutions and strengthen the research system.

Spaces for sharing knowledge

As part of our events programme, we provide forums where stakeholders can exchange perspectives and experiences about the challenges they face in their work, including through our Good Practice Forums and Roundtables.

Cross-sector collaborations

We lead projects that bring together diverse expertise to co-develop practical solutions to research integrity challenges, designed for broad adoption. A key example is our ongoing authorship project commissioned by UKRI (see below).

International advocacy

We engage with networks like the European Network of Research Integrity Offices (ENRIO) to align standards and strengthen integrity initiatives across diverse contexts.

A Look at our Authorship Workshops


As part of a UKRI-commissioned project, UKRIO hosted two collaborative workshops in March 2025, bringing together over 80 research contributors from diverse backgrounds – including researchers, research governance professionals, publishers, and funders – to co-develop tools for promoting good authorship practice.



Our priorities in 2025/2026

In our stakeholder survey, we asked the community to rank the issues they wanted us to address in this year's programme. Based on this feedback, we have selected four priority workstreams for 2025/2026.

Respondents ranked seven issues in order of priority

Artificial
 Intelligence

Al is transforming research, offering unprecedented opportunities while raising important questions about safe, rigorous, and ethical use. Over the past year, UKRIO has addressed these challenges through targeted projects and initiatives, and we will build on these achievements to help organisations and researchers navigate AI responsibly and effectively.

69%

Key activities:

• Develop practical resources to support responsible use, including a train-the-trainer toolkit and case studies for research governance staff.

- Engage with cross-sector initiatives to shape ethical and inclusive practices, like the University of Leicester's AI, Ethics and Inclusion project.
- Host a roundtable discussion exploring publishers' and funders' relationships with AI and its role in peer review.
- Share up-to-date insights and guidance on best practice, including a revised AI resource page.

2) Research Culture



Research culture as a key concern for integrity initiatives—as identified in past reports UKRIO has contributed to. Building on last year's work, we will continue to provide research contributors in all roles and contexts with the tools to foster a positive and integrity-driven research culture.

54%

of survey respondents ranked 'Enhancing research culture' in their top three concerns.

Key activities:

- Embed good authorship practice into research culture through tools developed as part of our ongoing UKRIcommissioned project.
- Strengthen institutional support by releasing revised guidance for establishing Research Integrity Champions.
- Deliver targeted training for subscribers, focusing on researcher wellbeing and promoting integrity-driven research environments.

3) Research Ethics



High-quality research relies on strong skills for navigating ethical dilemmas, and stakeholders have highlighted the need for more accessible tools and training. This year, we will address this need and help researchers uphold ethical standards at every stage of research.

52%

of survey respondents ranked 'Research ethics in practice' in their top three concerns.

Key activities:

- Provide subscribers access to an online research ethics training course, codeveloped with the University of Suffolk, equipping them to navigate ethical challenges confidently at every stage of research.
- Strengthen ethical governance by releasing updates to core tools co-published with ARMA, including a Research Ethics Framework, REC review panel checklist, and risk assessment matrix.

Our priorities in 2025/2026





Preventing and addressing breaches in research integrity

Breaches in research integrity from honest mistakes to deliberate misconduct - remain a major concern for research contributors. As highlighted in our 2024 report, significant barriers still prevent breaches from being consistently reported, addressed, and prevented. This year, our work will focus on advancing the report's recommendations, supporting research organisations to adopt fairer, more consistent, and transparent approaches to preventing and investigating breaches.


of survey respondents ranked 'Addressing breaches of research integrity' in their top three concerns.

Key activities:

- Train research organisations to investigate misconduct effectively through new live sessions and supporting materials.
- Provide practical tools to address breaches of integrity across diverse research settings via Detailed and Universal Misconduct Procedures.
- Increase accessibility of misconduct guidance by publishing an updated, organised catalogue of internal and external resources.
- Publish targeted guidance on nonethical research participation (with the University of Nottingham) to help prevent breaches of integrity.
- Contribute to sector-wide resources by supporting the development of an early career researcher research integrity toolkit (with Sense about Science and Taylor & Francis).

Confidential Advisory Service

UKRIO's longstanding Advisory Service is one of our most recognised offerings. Each year, we respond to enquiries from across the UK and internationally on a wide range of issues, including data fabrication and falsification, research ethics, authorship, publication practices, and governance.

This vital service provides confidential, expert advice while giving UKRIO unique insight into integrity challenges at individual, organisational, and national levels. We draw on our network of specialists—including the Advisory Council and Expert Community—to ensure diverse expertise informs every response.

Access our Advisory Service

Live Training and Education

UKRIO delivers tailored live training and consultancy, both in person and virtually, designed to meet the needs of research contributors across roles and contexts. Our sessions cover a broad range of topics, including:

- Introduction to research integrity and research culture
- Research ethics for early-career researchers
- Training for Research Ethics Committees (RECs)
- Publication ethics and authorship in research
- Implementing the Concordat to Support Research Integrity
- Organisational strategies to enhance research culture
- Research integrity and research culture for senior leadership teams
- Addressing breaches of research integrity, including investigating allegations of research misconduct
- Training for research integrity champions, advisers and similar roles

They provide practical support to help research contributors uphold integrity, navigate challenges, and embed best practice across all stages of research.

Thought Leadership and Community-building

UKRIO shapes the national conversation on research integrity by convening partners across the research ecosystem to develop community-driven solutions to integrity challenges. This enables research contributors to connect, share expertise, and help shape practical responses to emerging issues.

We support engagement at multiple levels:

- **Public opportunities**: Expert webinars, roundtables, and quarterly Connect with UKRIO events.
- **Subscriber opportunities**: Good Practice Forums and our annual research integrity conference.
- Collaborative projects: Periodically, we launch crosssector initiatives that bring together stakeholders from across the research community to tackle pressing integrity challenges.

Online Training Courses

In response to stakeholder feedback about limited access to research integrity training, UKRIO has prioritised the development and launch of online courses for subscribers over the past year. These flexible and engaging courses strengthen understanding of research integrity by combining interactive learning with practical tools for immediate use in day-to-day research.

Current and upcoming courses include:

- Introduction to Research Integrity (launched May 2025) builds a strong foundation in integrity principles and offers guidance on applying them in practice.
- Introduction to Research Ethics (pilot launching December 2025, co-developed with the University of Suffolk) equips researchers and research ethics committees (RECs) with skills and confidence to navigate ethical challenges.

Introduction to Research Integrity is a four-module course, refined through a pilot with nearly 9,000 participants from 100+ research organisations. Combining expert videos, case studies, and interactive activities, it offers a strong foundation in integrity principles and guidance for applying them in practice.






