This feedback has not only enabled us to reflect on our impact and areas for improvement but also shape our work programme for the year ahead.





# Top priorities



### Topics ranked in order of priority by stakeholders, on a scale of 1 to 7 (n=179)



#### Other suggestions noted in open text boxes included:

- Navigating international or interdisciplinary research collaborations
- The impact of the challenging environment e.g., mental health and wellbeing in research environments
- Research ethics in specific settings/contexts e.g.,
   non-regulated animal materials
- Systemic and cultural issues that may encourage breaches of research integrity e.g., authorship

### How UKRIO can best support



Strong themes emerged in stakeholder responses to how UKRIO can best support them and the wider research community to uphold and advance research integrity.

- Training was high on the agenda, with the online training course a welcome and valued addition to subscription – and requests to see this area develop further
- Many noted UKRIO's unique position in the sector as an independent body and expressed a desire to see us step up our efforts to convene actors across the ecosystem
- Stakeholders looked to UKRIO to be 'on the pulse' of changes and advise and guide on new and emerging challenges
- Stakeholders had a clear appetite for more opportunities to network and share good practice
- Stakeholders consistently emphasised the challenging environment for HE and noted how time and resource poor they were so any outputs need to be **practical**, **concise**, **and free or low cost**

## Thematic workstreams

### Artificial intelligence



Al has the potential to transform research – but it also raises concerns for research integrity.

We're working to address this head-on, with our recent releases:

- Embracing AI with integrity: a practical guide for researchers
- Additional content dedicated to AI in our Introduction to Research Integrity online course

This year, we'll be focusing efforts on turning guidance into practical actions and continuing to advance knowledge in this area.

#### **Key activities**

#### **Practical tools**

Develop practical resources, including a train-the-trainer toolkit and real-world case studies to support responsible Al use in research.

#### **Cross-sector initiatives**

Support cross-sector initiatives, including advising on NIHR Research Support Service (RSS) project led by the University of Leicester's to examine the use of generative AI in qualitative data analysis and the implications for ethical conduct, trust, recruitment and research inclusion.

#### Roundtable

Host a roundtable bringing together research organisations, publishers, and funders to discuss the use of AI in research – and the respective roles of each to ensure it is used responsibly.

#### **Central resource**

Help the research community stay informed about the latest AI developments through a regularly updated resource page that consolidates key reports, guidance, and examples of good practice in one central location.

### Research culture



It is widely acknowledged that fostering a positive research culture is essential to strengthening research integrity. This was evidenced in the report *Enablers and Inhibitors to Research Integrity*.

The report found that aspects of research culture, such as pressures to publish and quantity-focused assessment metrics, act as major systemic inhibitors of research integrity. In contrast, mentorship, positive role models, and training were evidenced to be key enablers.

This year, we convened a roundtable with stakeholders to explore key considerations in advancing and embedding a healthy research culture, including adaptability and change, awareness, and recognition and rewards.

Building on these insights, this year we will work with specific roles within the research environment.

#### **Key activities**

#### **Practical tools**

Embed good authorship practice into research culture through tools developed as part of our ongoing UKRI commissioned project, *Supporting collaborative* thinking and progress on discussing authorship disputes.

#### **Institutional support**

Strengthen institutional support by releasing revised guidance for establishing Research Integrity Champions to foster a culture of integrity.

#### Subscriber training

Deliver targeted training for subscribers, focusing on researcher wellbeing and promoting integrity-driven research environments.

#### **Expert webinar**

Host an expert webinar on the role research supervisors play – and practical strategies they can employ to foster an inclusive and positive research culture.

#### Support

Support a project led by Sense about Science and Taylor & Francis to develop an integrity toolkit for early career researchers.

### Research ethics



Our stakeholders have identified this as a critical area of need, with requests for training in research ethics, especially for Research Ethics Committees (RECs), among the most frequent we receive.

So, this year we're making it a priority to develop practical, accessible tools, training and guidance to support ethical decision-making at every stage of the research process.

We'll also be addressing ethical challenges that arise in specific contexts – such as interdisciplinary research and international collaborations, or research involving animal materials, ensuring researchers are equipped to act with integrity, whatever the setting.

#### **Key activities**

#### **Online training**

The development, in collaboration with the University of Suffolk and our online training working group, of a suite of online modules around different aspects of research involving human participants, to provide researchers with a strong foundation to navigate ethical challenges.

#### **Updated guidance**

Releasing a revised and updated version of the UKRIO/ARMA `Research Ethics Support and Review' guidance, to include the development of supplementary materials (REC review panel checklist, audit tool, risk assessment matrix) and ensure that these are relevant for a broad range of research organisations.

#### **Good Practice Exchange**

Convening a meeting for subscribers who are members of, or who support, Research Ethics Committees to discuss challenges and share experiences and approaches.

#### **Roundtable and Expert webinars**

We will be hosting roundtable discussions and an expert webinar on:

- Ethical considerations in international and interdisciplinary research collaborations
- · An ethical framework for the use of animal materials.

## Breaches in research integrity



Breaches in research integrity – from honest mistakes to deliberate misconduct – remain a major concern for research contributors. We continue to receive many queries about these through our enquiries service.

Our 2024 report, *Barriers to Investigating and Reporting Research Misconduct*, identified key areas of work for UKRIO to action.

This year, our work will focus on supporting research organisations to adopt effective, consistent, and transparent approaches to preventing and investigating breaches.

#### **Key activities**

#### **Practical tools**

Developing practical resources, including piloting a train-thetrainer toolkit with case studies, to train and support those responsible for investigating alleged breaches of research integrity.

#### Detailed and universal misconduct procedures

Reviewing and updating the UKRIO Procedure for the Investigation of Misconduct in Research and publishing a new abridged `Universal procedure' for investigating breaches of research integrity – step-by-step manuals and templates for research organisations to use or adapt as they see fit.

#### **Cross-sector initiatives**

Contributing to various cross-sector initiatives, including:

- A project led by Wellcome and UKRI to develop learning modules on data sharing in research misconduct cases
- UKCORI's work to examine poor research practice and research misconduct.




### Subscriber network
