UKRIO is an independent charity that supports the research community to **uphold the highest standards of integrity**. We promote ethical, reliable, and honest research that delivers real benefits to society.

- Provide high-quality training, advice, and guidance
- Lead and shape national research integrity dialogue and initiatives

The need for our work has never been greater. Challenges to research integrity are on the rise – including risks associated with the proliferation of AI, predatory publication practices, and financial pressures within sectors like higher education.

Now more than ever, researchers and organisations must be proactive in upholding good practice. We provide the resources, guidance, and support to help them do just that.

Guided by feedback from the research community, we have taken significant strides to **deepen our impact in 2024/2025** – offering support on emerging challenges, expanding training services, building crosssector collaborations, and more.

# Responding to the sector's most pressing challenges

After extensive consultation with stakeholders about the most pressing challenges they face – and gaps in existing support – we identified **four priority areas** to focus on in 2024/2025.

#### **Research misconduct**

- Advanced proposals from our 2024 report Barriers to Investigating and Reporting Research Misconduct
- Co-published guidance with Protect, the national whistleblowing charity, to support whistleblowers in research settings
- Advocated for terminology changes to improve research misconduct investigations

#### Artificial intelligence

- Published *Embracing AI with integrity*, a practical guide to help researchers use AI responsibly
- Hosted a public webinar on AI and research integrity with experts from the Royal Society and the University of East Anglia
- Facilitated a roundtable discussion with subscribers to review and improve our guidance on Al
- Delivered bespoke training on navigating Al-related issues in research settings

#### Authorship disputes

- Led a cross-sector project to improve authorship practices in the UK, convening 80+ stakeholders to develop new guidance and tools for public-use
- Held a roundtable discussion with subscribers on authorship practices in research publications

#### **Research culture**

- Delivered bespoke training to senior leaders on embedding integrity into organisational culture
- Hosted a public webinar on research culture with experts from Loughborough University and the University of Leeds

# Empowering researchers to act with integrity

A recurring concern raised by stakeholders has been the limited availability of **high-quality**, **accessible support** to help research practitioners embed integrity in their work. This year, we focused on closing that gap.

#### Online training

Our new Introduction to research integrity course offers an engaging, accessible way for researchers to strengthen their work through the principles of research integrity. Refined through a year-long pilot, it provides practical guidance on applying integrity in real-world contexts, covering topics such as research ethics, conflicts of interest, data management, authorship, and Al. To date, **over 9,400 users have registered**.

#### **Advisory service**

Our longstanding advisory service continues to be a vital support system for the sector, offering expert, confidential advice on research integrity matters to institutions, funders, publishers, and the public. In 2024/25, we fielded **over 120 enquiries** on a range of topics, including authorship, research misconduct, research ethics, research data and IP.

#### Training and guidance

- Expanded our bespoke training offer to include **9 sessions** tailored to different audiences, including early career researchers, senior leaders, and research ethics committees
- Published over 25 new resources including guidance, practical tools, and videos – on topics in research integrity

# Building a culture of integrity

At UKRIO, we are firmly committed to cultivating a shared culture of research integrity.

This year, we engaged in **crosssector initiatives** that brought together perspectives from across the research landscape to develop effective and collaborative solutions together.

#### Our cross-sector initiatives in 2024/2025

- Convened **authorship workshops** with research organisations, publishers, funders, and government to develop tools to support good authorship practices
- Hosted our annual **subscriber symposium** with 180+ participants and leading voices from the research landscape, including MP Chi Onwurah, Chair of the Science, Innovation, and Technology Select Committee
- Partnered with the European Network of Research Integrity Offices (ENRIO) to map and compare research integrity definitions across Europe
- Contributed to the **Animal Materials Working Group**, led by the Sanger Wellcome Institute, to develop an ethical framework for sourcing materials from sentient animals
- Provided input as a member of **UKCORI's working group** examining the national systems for handling research misconduct and poor practice
- Contributed to the revision of **The Concordat to Support Research Integrity** prior to its publication in April 2025

# Working with a growing network

At the heart of our work is a diverse and expanding network of organisations and individuals committed to enhancing research integrity practice.

**UKRIO subscribers** – over 150 organisations from across disciplines and sectors who actively support and engage with our work

**Expert community** – a group of 35 specialists from varied fields who ensure our guidance is accurate, relevant, and informed by realworld expertise
